Dear St. Ignatius Parent / Student:

Once again, Barnes School Bus Transportation will be providing shuttle service to / from St. Ignatius from the Ogilvie Station (formally known as Northwestern), LaSalle Street Station and Union Station for the 2009-2010 school year.

The morning pick-up schedule is as follows:

**We ask that your child arrive at the train station at least 5 minutes early to ensure the punctual departure of our shuttle buses. Before agreeing to utilize the shuttle bus service, please carefully review the above schedule as well as refer to the various train schedules, to determine if this service will be beneficial to your child.**

The after school shuttle will depart from Saint Ignatius for the train stations at 3:05 pm. For students that are involved in after school activities, a second bus shall depart at 5:30 pm. On Late Start days, the shuttle bus will always run on its regular schedule. A special schedule will be implemented on early dismissal days, etc. and will be announced to the students during homeroom time.

The price for the shuttle service is \$715.00 for the **entire school year**.

This fee **WILL NOT BE PRORATED** and is **NON-REFUNDABLE**, unless special arrangements have been made, in advance, with Barnes School Bus Transportation.

Enclosed is a registration agreement for the shuttle service. Please fill out in its entirety- **INCOMPLETE AGREEMENTS WILL BE RETURNED UNPROCESSED**. Each student should utilize a separate form. You will also find the rules and regulations that students will be held responsible for throughout the school year on any Barnes School Bus Transportation vehicle. The rules and regulations are strictly enforced for the safety and well being of all our passengers. Therefore, the signatures of both a parent and the student riding the bus are required on the rules and regulations form.

Please complete your agreement and mail it along with payment before July 31st. Payments should be made by check or money order and should be mailed directly to:

It is important that your completed agreement and payment is received before July 31, 2009. If there is not a sufficient amount of interest in the morning and afternoon shuttle program, it will not be offered and all payments will be refunded in full.

Upon the receipt of your application and fee, you will receive, in the mail from Barnes, your child's shuttle bus pass. A bus pass must be presented at the boarding of the bus. There is \$20 replacement fee for lost bus passes. Please contact Barnes directly to receive a replacement pass.

I understand that by signing this registration agreement for bus service during the 2009-2010 school year, I am agreeing that my child will comply with all Barnes School Bus Transportation rules and regulations. I understand that I am contracting service with Barnes School Bus Transportation Co. for both semesters of the 2009-2010 year and that this fee is non-refundable unless special arrangements have been made in advance. There will be a \$25.00 handling charge for returned checks. There will be a \$20.00 charge for replacement passes. I further understand that my child's riding privileges will be suspended if any financial obligations are not met.

**RULES & REGULATIONS**

1. The student's bus pass must be shown each and every time they board the bus. Students will be refused rides if they are unable to present a pass or school identification to the driver.
2. The bus pass is non-transferable to another student. If used in this manner, the pass will be confiscated. If not reported missing or stolen ahead of time, the student(s) involved will lose their riding privileges as well as forfeit all payments.
3. Lost passes should be reported to Barnes immediately. Should a permanent replacement pass be needed, there is a \$20 charge. **The student should contact Barnes directly to obtain a replacement pass.**
4. While waiting for the bus, students are expected to show proper respect for property and the possessions of others, be it fellow students or other citizens.
5. Insubordination or verbal abuse directed toward the driver will jeopardize riding privileges.
6. Heads, arms and legs are never to protrude out of the windows of the bus. Nothing is to be thrown out of the windows.
7. Riders must remain seated while the bus in motion.
8. Riders who vandalize the bus will be billed for the damages and will lose riding privileges, as well as forfeit all payments.
9. Riders are never to assume the position of the driver or manipulate the bus controls. Riding privileges may be revoked and all payments forfeited for such actions.
10. Drugs, smoking, chewing tobacco, fighting, eating, drinking and roller blades are not permitted on the bus.
